CONTRACT RULES & REGULATIONS:

We hereby abide with following terms & conditions

The entire prescribed form which is in duplicate is a part of the contract & once signed means it is accepted by the exhibitor.

- 1. The stall will be allocated on first come first basis provided the entire payment is received as per the terms. The payment has to be made by account payee cheques /demand draft drawn in favor of "FIAA/c Gujtech2012" payable at Ahmedabad.
- 2. The participant charges are only for prefabricated stall with the standard facilities only. Incase of Indoor bare space this comprises of bare space only, while Exhibitors shall have to construct their own designed stall.
- 3. If the payment schedule for the stall is not maintained, we are at liberty to cancel the same.
- 4. Organizers reserves the right to reallocate space, change the layout if required for the betterment of the project at large.
- 5. As far as the power is concerned, it shall be available at 230 V single phase & 400 V three phase A C 50 cycles. Additional rates per HP shall be charged & the charges are subject to revision.
- 6. The Organizers are supposed to provide electricity at suitable point in the stall. Any additional internal distribution for the machinery and equipments will have to be arranged by the exhibitors through electrical contractor.
- 7. As regarding the requirement of water it has to be informed in the booking form above 200 Ltr barrel.
- 8. Compressor: This facility shall be provided at an extra cost provided it is written at the time of booking.
- 9. A minimum of 35% of the stand space must be left free for the movement of the visitors by the Stall owners & any alternation shall be made only after the pre-approval by the Organizer.
- 10. The stall owners can have video/animation films of their products within the stands but the sound level has to be very low & should not disturb the visitors or the stall owners. The use of loudspeakers or other musical instruments can not be used.
- 11. Sales at the Exhibition is not permissible but meetings for the negotiations are always possible.
- 12. Those stall owners who are going to design to their stalls shall have to get the drawings approved by us before 15th of December 2011 & leiu of failing to do so, we shall charge a penalty @Rs1000/- per day w.e.f15th December 2011
- 13. Security: The Organizer shall appoint the quality security personnel during the Exhibition period & nobody shall be allowed to stay after the Exhibition hours. Organizers are not responsible for the loss and theft of any article material or display.
- 14. Photography: The organizers reserves the right to photograph any exhibit for their use
- 15. Insurance: The organizers shall take Insurance of the event & any other insurance related to stall owners or their personnel shall be responsibility of the individual stall owner.
- 16. Clearing & Forwarding facility: or services for handling of the goods shall be available at the Exhibition at an extra cost & no other agency other than official agency shall be allowed at the ground.
- 17. Damages at Exhibition ground: In case of any damages or losses caused to the stalls, structure, or any other similar loss shall have to be reimbursed by the stall owner & the recovery cost shall be decided by the organizers & has to be cleared off before leaving the Exhibition.
- 18. Octroi: Since Octroi charges are not applicable in Gujarat, the Exhibitor has to complete the R-form formalities at the starting point & only then proceed to the Exhibition ground
- 19. FORCE MAJEURE: In case of Exhibition being abandoned, cancelled or suspended by any reason beyond the control of the organizers like: War, fire, natural calamity, national emergency, election, riots, strike etc-the organizers reserves the right to change the dates & duration.
- 20. Exhibition Directory: The information of every stall owner shall be provided in the Directory to be launched during the Exhibition provided it is given at the time of booking the stall. Every Exhibitor shall be eligible for one complimentary copy of the same.
- 21. In event of any dome as per the theme is not fully sold we are at liberty to allot the stall to the Exhibitor in any relevant sector.
